1. Call to Order/ Welcome New Commissioners

The meeting was called to order at 3:00PM PM Eastern Time by President Hanson.

Chairman Ryan Silvey (MO) noted that Commissioner Glen Kolkmeyer was recently appointed to the Missouri Public Service Commission, and was participating in his first MARC meeting.

2. Minutes and Secretary's Report (Commissioner Scripps)

The minutes from the February 8, 2021 MARC Board meeting were presented by President Hanson.

The minutes were moved by Commissioner Coleman (MO), seconded by Commissioner Huston (IN), and adopted by the Board.

3. Treasurer's Report (Commissioner Sieben)

The Treasurer's report was presented by Treasurer Sieben. The only significant expense was a site deposit relating to the MARC 2022 meeting in Chicago; other expenses included Bill.com and other routine expenses. The Treasurer's report was moved by Commissioner Bocanegra (IL), seconded by Commissioner Freeman (IN), and adopted by the Board.

In addition, Treasurer Sieben reported that she is in the process of removing Commissioner Oliva as an official signatory on the MARC Wells Fargo account, and adding Commissioner Scripps.

4. President's Report (Commissioner Hanson)

Transition of MARC Accounting Support

President Hanson provided an update on transitioning of MARC's accounting support to LTEVA Contractor Services, and noted he had sent an email with background documents to the Board. He is supportive of making this transition, with the formal vote postponed to allow for Board members to review the materials and discuss in person at the next MARC meeting.

Appointment of Vice President, Executive Committee Member

President Hanson informed the Board members of two appointments he made pursuant to the MARC Bylaws following the resignation of Illinois Commerce Commissioner Sadzi Oliva. To fill the position of Vice President, President Hanson appointed Wisconsin Commissioner Ellen Nowak, who had been serving as the At-Large Executive Committee Member. To fill the open At-Large Executive Committee Member, President Hanson appointed Illinois Commissioner Maria Bocanegra.

2022 Annual Conference

President Hanson also appointed Illinois Commissioner Bocanegra to serve as President of the 2022 Annual Meeting. This has been done before for past MARC conferences, and will better position Commissioner Bocanegra in securing fundraising support and speaker confirmations.

President Hanson also recommended that Illinois be provided a "loan" in the amount of \$20,000 to cover initial expenses related to the 2022 annual meeting prior to when sponsorship dollars are realized. Providing initial financial support in this amount was moved by Commissioner Ridder (NE), seconded by Commissioner Anthony (OK), and adopted by the Board.

5. Vice President's Report (Commissioner Nowak)

There was no Vice President's report for this meeting.

6. Executive Committee's Report (Commissioner Bocanegra)

There was no Executive Committeemember's report for this meeting.

7. Old Business

Beyond the items covered in the President's report, there was no additional old business for this meeting.

8. New Business

Update on 2022 MARC Annual Meeting

Commissioner Bocanegra provided an update on planning for the MARC 2022 meeting in Chicago, which will take place from Sunday, June 19, 2022 through Wednesday, June 22, 2022 at the Radisson Blu Aqua hotel. The Illinois planning team is working to secure the Shedd Aquarium for the opening reception on Sunday night, both for its iconic views of the Chicago skyline, and also to spotlight the Aquarium's onsite microgrid and energy plant.

The planning team is also seeking volunteers for the conference, as well as asking for help in leveraging the networks of MARC members for keynote and other featured speakers. Commissioner Bocanegra also shared a survey to inform the development of content for the meeting.

• Gift in appreciation of Cindy Kemnitz's efforts

President Hanson noted that the Executive Committee had recently supported the idea of recognizing the efforts of Cindy Kemnitz by providing her with a \$3000 gift. Cindy has been a key element of MARC's work over the past several years, assisting with a range of accounting

duties and in the preparation of the regular Treasurer's reports. Current Treasurer Sieben also spoke to the valuable role Cindy has played, and spoke in favor of making the gift. Commissioner Keen (KS) formally moved that MARC provide Cindy Kemnitz with a gift in the amount of \$3000, which was seconded by Commissioner Anthony (OK), and adopted by the Board.
