Transition of MARC Accounting Support

President Nowak provided an update on transitioning of MARC's accounting support to LTEVA Contractor Services. The transition has been going well, but there are many steps and a lot of communication between MARC and LTEVA. Soon fully transition away from Cindy to LTEVA.

Location of MARC commissioner-only meeting will be on the agenda for February board meeting. Recommend moving to second week of January to provide more time between holidays. Prefer somewhere in the southern part of the MARC footprint with direct flights.

5. Vice President's Report (Commissioner Sieben)

There was no Vice President's report for this meeting.

6. Executive Committee's Report (Commissioner Bocanegra)

Commissioner Bocanegra reported on preparations for the annual meeting. The committee has prepared a low, medium, and high case with estimated net revenues of \$85,000, \$102,000, \$213,000 respectively.

The MARC website is being updated. Contracted with Event Ray to open registration portal and payment connections have been made. Registration will open late January. Price points are comparable with other conferences and NARUC.

Sponsorships are at \$58,000 as of this date and include GTI and Oracle. Potential events include tours of Shedd Aquarium microgrid, Rivian ride-and-drive, EV ride-and-drive, tours of Hardine plant, Invenergy and Green Arrow RNG facility.

Need to clarify whether we have maintained non-profit status with IRS. If not, we are required to pay taxes on any revenue. Last certification online was from 2011.

PUF will work with the MARC conference, interviewing president and commissioners to market the conference. Looking for moderators, speakers, keynotes, etc. On track and doing really great with preparations.
